January 15, 2025:

• Fourth quarter 2024 estimated tax payment due for individuals and corporations.

January 31, 2025:

- Provide Form 1099-MISC and 1099-NEC to recipients and file them with the IRS
- File Form 940 (FUTA tax return for 2024).
- File Form 944 (annual return for small employers).
- File Form 945 (annual return for nonpayroll withholding).

February 10, 2025:

• Extended deadline for Forms 940, 941, 943, 944, and 945 if all taxes were deposited on time.

February 17, 2025:

• Deadline for sending Form 1099-B to recipients.

February 28, 2025:

Paper filing deadline for Form 1099-MISC with the IRS.

March 17, 2025:

- File Form 1120-S for S-corporations.
- File Form 1065 for partnerships and multi-member LLCs.
- Distribute Schedule K-1 forms to partners or shareholders.

May 1, 2025:

In light of the recent hurricanes, the IRS has extended certain tax filing and payment deadlines for affected individuals and businesses. For those impacted by Hurricanes Helene and Milton in Florida, the new deadline is May 1, 2025. This extension applies

- 2024 Individual and Business Tax Returns: Normally due in March or April 2025.
- 2023 Tax Returns with Valid Extensions: For individuals, C corporations, or tax-exempt organizations.
- Quarterly Estimated Tax Payments: Including those due on January 15, 2025, and April 15, 2025.
- Quarterly Payroll and Excise Tax Returns: Normally due on October 31, 2024, January 31, 2025, and April 30, 2025.

June 16, 2025:

• Second quarter estimated tax payment due for individuals and corporations.

September 15, 2025:

- Third quarter estimated tax payment due for individuals and
